Background Information:

Pacific Cancer Foundation (PCF) was founded in 2005 and our mission is to provide Access, Knowledge, and Support to all those affected by cancer in Maui County.

Pacific Cancer Foundation serves as a beacon of support for cancer patients and their caregivers in Maui County, offering crucial services both before and after the fires that devastated Maui in August 2023. We provide compassion and critical services to those affected by cancer and do that in a range of ways.

PCF's dedicated staff forms the backbone of the foundation, bringing a unique blend of experience, empathy, and specialized skills to support individuals and families navigating the challenging journey of cancer in Maui County.

Patient Navigator: PCF's highly trained Patient Navigator brings a personal understanding of the challenges faced by those affected by cancer. She navigated her husband through the complex medical system for four years until his passing in 2021 and combines empathy with practical knowledge. Our Navigator also lost nearly everything in the Lahaina fire but continues to support other fire victims as well as cancer patients across the county. This firsthand experience equips her with a unique perspective, allowing her to guide individuals through the intricacies of the healthcare and other systems with compassion and insight.

Care Coordinator: PCF's Care Coordinator is known for her exceptional organizational skills. She coordinates airfares, Uber rides, and lodging accommodations for multiple people each week, easing the logistical burdens faced by individuals and families dealing with cancer. Her efficiency ensures that practical challenges are addressed promptly, allowing clients to focus on their health. She also lost almost everything in the Lahaina after the fire.

Registered Dietician: PCF's Nutritionist has over 20 years' experience and has worked in both clinical settings as well as private practice. Her thorough understanding of the needs of cancer patients and heartfelt compassion are a valuable asset to the PCF team.

Wellness Facilitators: PCF's wellness facilitators have over 20 years' experience in meditation and Qi Gong. They provide a holistic approach to well-being and resilience.

Support Group Facilitators: PCF facilitators provide support groups for both cancer patients and caregivers and not only possess the necessary professional qualifications but also embody great levels of compassion and support.

Amount of Funding Requested: \$25,000.00

Target Needs:

Simply stated, the largest problem facing the people we work with is cancer. However, cancer is a multifaceted challenge that affects each person and their loved ones differently. Cancer was challenging our clients even before the fires devastated our island. The combined stresses of cancer and the trauma of the fires are compounded for some of our clients and most of our staff. Even as patients from Lahaina temporarily postponed their treatments due to evacuation concerns, PCF provided continuous support, recognizing the urgent need for normalcy amid the profound disruption caused by cancer, where, as one woman poignantly expressed, "chemo is my 'normal.'" Since August 8th, we continue to work with over 70 people who were affected by the fires, most of them were from Lahaina. Both of our direct service staff also lost their homes and possessions in the Lahaina fire.

And we continue to work with hundreds of cancer patients who were not directly affected by the fires. The needs of all of PCF's patients vary greatly, so our Patient Navigator and Care Coordinator work hard to learn about each family and their individualized needs and find helpful solutions.

PCF's Transportation and Lodging services are invaluable help to cancer patients who often need to travel to Honolulu or to the mainland for tests, treatment and support. On a regular workday we help multiple people with Uber rides to treatment right here on Maui, too. In the aftermath of the fires, as families faced the loss of essential possessions, including vehicles, multiple family members often find themselves sharing a single car so our support services became crucial in ensuring cancer patients could access medical appointments. Nutrition services provided by PCF took on added significance, recognizing that the compounding stress from the fires, coupled with the inherent stresses of cancer, can significantly impact individuals' eating habits.

As we navigate this challenging terrain, the importance of Meditation, support groups, and other wellness activities offered by PCF cannot be overstated. These initiatives play a critical role in reducing stress and supporting overall health, acknowledging the interconnectedness of mental well-being with physical health during times of crisis.

Additionally, PCF also faces a substantial funding deficit exceeding \$400,000 due to the cancellation of 3 major fundraisers which would have been held shortly after the fires. PCF remains committed to our mission, reaffirming our support for those affected by cancer and by the fires in Maui County.

How PCF Addresses the Target Needs:

The Pacific Cancer Foundation (PCF) provides free support services to cancer patients and their caregivers including Oncology Lay Navigation, Dietitian Services and Nutritional Supplement Support, Transportation and Lodging for both cancer patients and their caregivers, Support Groups (Cancer Patient Group, caregiver group, and Men's Talk Story), Wellness Classes (Qui Gong and Meditation), Food Pantry for food insecure families, Wig and Breast Prosthesis Fittings, Assistance for Access to Financial Subsidies, and ongoing Education.

Pacific Cancer Foundation's program activities support individuals and families navigating the complex journey of cancer. We believe in individualized support created and directed by the person with cancer and their caregivers. The Patient Navigation program offers comprehensive support and case management from diagnosis through treatment planning, follow-up, and potentially into remission or hospice care, providing a continuous line of support for families throughout the entire cancer journey. PCF has many partners in this journey including oncologists, Pacific Cancer Institute (radiation), the Chemotherapy unit (Infusion) at the hospital, and other non-profits including Hospice Maui.

After requests for cash assistance, Transportation continues to be the request cancer patients need most. Each week, our Care Coordinator dispatches dozens of volunteers, non-profits, and Uber/Lyft rides for patients on Maui to attend doctor appointments, tests, or treatment. Other major requests are for travel off island, especially from the islands of Molokai and Lanai where there is no cancer treatment on their own islands. Our Care Coordinator books these flights, and arranges ground transportation and lodging for clients and their caregivers at no cost to the families. Our partners in the Transportation and Lodging Program include American Cancer Society and their beautiful Hope Lodge on Oahu, Uber Health, Lyft Concierge Service, MEO Paratransit, volunteers from Na Hoaloha, various hotels and Charlie's Taxi in Honolulu.

Nutrition support with our Dietician begins at the point of diagnosis and follows throughout the entire cancer journey. Cancer patients need to maintain their health, especially those with feeding tubes. PCF provides cases of Ensure, Glucerna or Kate Farms liquid supplements at no charge to our clients. PCF offers meditation and Qi Gong classes. These activities are meant to alleviate stress and contribute to the overall well-being of those in our care. Our partners in these classes are the practitioners themselves who care so deeply for the people we serve.

PCF's weekly support groups are tailored for both patients and caregivers. These groups provide safety, empathy, emotional support, and connections with others on similar journeys and breaks the isolation that often affects people with cancer and their caregivers.

PCF's comprehensive services play a pivotal role in supporting cancer patients during their recovery and stabilization phases. PCF's full range of services is designed to address the already challenging journey of those navigating the complex intersection of cancer treatment and post-disaster recovery.

Demographic of PCF Clientele:

Pacific Cancer Foundation helped nearly 1500 people with cancer last year alone. Of these, 47% identified as male, 52% as female and about 1% as "other." In terms of racial backgrounds our largest race served is White/Caucasian (38%), then Asian (35%), Native Hawaiians (24%) and American Indian and "other" making up the remainder. The age of the cancer patients are usually older with 60% being between the ages of 60 and 80, only 5% under 40 years of age and about 25% between 40-60 and 11% are 80 and older.

Pacific Cancer Foundation works with patients who have every kind of cancer you can imagine. In descending order, here are the higher numbers: breast cancer (30%), lung (19%), prostate (10%), colon (7%), stomach, skin, pancreatic, ovarian, leukemia, brain, etc. are all under 4%.

Geographic Region Covered:

PCF serves all of Maui County which includes the islands of Maui, Moloka'i, and Lanai.

How the Dorcy Foundation Grant Money Would Make a Difference to PCF and our Clientele:

PCF upholds a robust and varied funding framework encompassing grants, fundraising initiatives, contributions from individuals and corporations, beneficiary events, an annual appeal, and funding from private and government grants. The Dorcy Foundation grant stands out as a crucial and consistent benefactor that has upheld our organization's stability during economic downturns, the challenges posed by the COVID-19 pandemic, the wildfires, and periods of donor fatigue. Reliable and flexible funding sources like this are scarce and invaluable to organizations such as PCF.

The financial support received, including the invaluable Dorcy Foundation grant, is earmarked for sustaining operational administration and covering program expenses. PCF expresses profound gratitude for the unwavering support it has received and earnestly looks forward to the possibility of securing this grant once again.

Projected Primary Funding Sources for PCF for FY24: (July 1, 2023 – June 30, 2024)

PCF's operating budget is just under \$500,000 for this fiscal year.

PCF's primary sources of funding include:

- American Cancer Society Transportation and Lodging grants
- PCF's major fundraising events: Paddle for Life and Aloha Kalikimaka (which were cancelled in 2023 after the fires in August)
- Hawaii Community Foundation (multiple trusts and foundations as well as the Maui Strong Fund)
- Maui United Way
- Other PCF fundraisers including an annual mailout, online auction and smaller awareness events.
