- Ka 'Ohana Kitchen feeds community members, no questions asked, a free hot meal every Sunday.
- Staffed by church and community volunteers.
- Served 2935 meals in 2020.
- Majority of clients are homeless. 75% are male. 5% are children.
- 2019 financial report indicates \$7,267.46 in kitchen equipment was purchased.

2022: 3678 meals served – many to unsheltered individuals.

- Anticipated kitchen operating expense is \$15,500.
- Needs new commercial dishwasher.
- Application states \$1,936 was received in donations toward the kitchen in addition to \$5,000 Dorcy grant.

2023: Annual cost is \$15,000 - \$5000 from Dorcy, \$3200 from community.

I write to you as the Rector of The Parish of Good Shepherd Episcopal Church in Wailuku, Maui, Hawai'i where we have been the beneficiary of numerous grants from the Laurence H. Dorcy Hawaiian Foundation Grant for *Ka 'Ohana Kitchen*, a weekly outreach feeding program that provides Sunday meals to members of the Wailuku community who are in need, many of whom are residentially challenged.

The Parish of Good Shepherd Episcopal Church would like to request \$10,000 from Laurence H. Dorcy Hawaiian Foundation Grant to cover expenses for this program to help cover the approximate cost of expenses that exceed \$15,000 to cover utility fees, property insurance, ingredients, and supplies (like biodegradable containers). In addition to the grant that the Laurence H. Dorcy Hawaiian Foundation Grant provides, we also solicit and receive contributions from our parish community and the wider Wailuku community. In 2023, \$3024.00 were received and added to Laurence H. Dorcy Hawaiian Foundation Grant.

Due in great part to your support, Ka 'Ohana Kitchen is well known in Wailuku, and much appreciated by those we serve as well as constituents in the wider community, especially after the Maui Wildfires on August 8, 2023 where many residents were displaced and relocated to the Wailuku area.

We have a "no questions asked" hot meal served after church services every Sunday from 12:30 PM to 1:30 PM and for many, it is the only nutritious meal that they eat throughout the week. In addition, this ministry is a collaborative effort, and we work with various community groups in Maui. We continue to partner and share this very important ministry with our friends in the community to the point where over the past 20 years we work with seven church teams and seven additional teams from the community, including the Rotary Club, Eco Club, Christian groups, health workers, and families and friends who are concerned about feeding those who face economic challenges. Furthermore, to date have not missed a Sunday offering of a hot meal to our community. At the present time.

In 2023, we served 5112 meals, 964 more people than the previous year.

The Parish of Good Shepherd Episcopal Church is a 501(c) (three) nonprofit organization, Federal Tax ID# 99-030448. We were last audited on August 2023 by in house committee for the year ending December 31, 2022. I have enclosed that along with the financial report for 2022 for your review and ready reference.
