REQUEST TO LAURENCE H. DORCY HAWAIIAN FOUNDATION

HUGS (Help Understanding & Group Support) For Hawaii's Seriously Ill Children and Their Families requests **\$25,000** in general operating support to assist Hawaii families in their challenging journey of caring for a child with a life-threatening/serious illness.

HUGS' MISSION: To strengthen Hawaii's families by improving their quality of life as they face the emotional and financial hardships of caring for a seriously ill child

ORGANIZATIONAL HISTORY AND BACKGROUND: HUGS was founded in 1982 by a small group of volunteers from Unity Church on Oahu who recognized that families with seriously ill children faced financial, spiritual, emotional, and other challenges related to their child's illness, and felt that they should not have to go through that journey alone. They envisioned an organization that would provide support, compassion, and aloha to these families.

Initially called the "Center," it was renamed the Young People's Support Center, and in 1989 the name was changed to HUGS (Help, Understanding & Group Support) by a family receiving support for their son who had a cancerous tumor. "When your child is diagnosed with a terminal illness, sometimes the only thing even a doctor can do is give you a hug," said Pleaman Shaver. "There are days when I wake up wanting nothing more or less than a big hug. It says so much -- I care, I hurt with you, hang in there."

HUGS is the only organization in Hawaii offering comprehensive, long term support services to children with life-threatening illnesses AND to their family members. We are unique among other Hawaii nonprofit organizations serving similar clientele in that HUGS:

- Serves children with a variety of life-threatening illness, not just a single illness (e.g. cancer)
- Serves all family members, including the ill child, Mom, Dad, and siblings - with individually designed programs.
- Is a local, homegrown nonprofit organization with no chapters outside of Hawaii.
- Is not affiliated with any national organization.
- All funds raised stay in Hawaii to benefit Hawaii's families.

In 2023 we served 378 families (1,655 family members), including 272 on Oahu, 5 on Molokai, 40 on Maui, 1 on Lanai, 12 on Kauai, and 48 on the Big Island. Of the 378 families served, 24 are active duty military, and 6 are retired military.

HUGS recognizes that when a child is diagnosed with a serious illness, each family member is impacted in different ways. Our programs are designed to meet the individual needs of each family member to strengthen their coping skills and to build family resiliency. These programs include:

1. *Peer Support* activities, such as monthly family gatherings and Mom and Dad-specific activities provide a safe environment of mutual understanding and build supportive networks with others in similar situations;
2. Monthly and emergency *respite* services to help ill children and their siblings gain a sense of normalcy and independence while their parents receive needed relief from the 24/7 worries of caregiving;
3. Weekly *hospital visits* and activities for hospitalized children;
4. *Case management* services to connect families with community resources to meet their needs (e.g. monthly food baskets, rental assistance, utility payment assistance, employment resources, etc.);
5. Emergency *airfare assistance* from neighbor islands or to the mainland for specialized medical treatment;
6. *Sibling Support* activities include a 3 day/2night SibCamp to help siblings of ill children build peer support and process their emotions and perceptions of their role in the family in a fun, nurturing environment.

All of our programs and services are provided to families free of charge. Eighty-five (85%) of HUGS families have low to moderate household incomes, often as a result of one parent losing employment to care for their ill child.

In total, HUGS provides nearly 50 peer support and family activities each year, all coordinated and implemented by HUGS' dedicated staff of seven (7) trained professionals, with assistance from 900+ trained community volunteers.

THE NEED: When a child is diagnosed with a serious/life-threatening illness, the journey for our HUGS families begins with shock and upheaval, followed by complex and prolonged medical treatment, financial hardship, unrelenting emotional distress, and anxiety –lasting for several years, until remission, or bereavement - and affects each member of the family in unique ways. HUGS family members have expressed that one of their most important needs is support from others who have experienced what they are going through. HUGS programs are designed to assist children and family members in making those connections so they can build a community of support around them. This support system aids in normalizing their fears and concerns, reduces anxiety and social isolation, and strengthens their ability to successfully cope and adapt to their child's diagnosis. National research confirms that critical peer support systems positively impact family health and the health outcomes for ill children.

IMPACT OF DORCY FOUNDATION FUNDS

Funds from the Laurence H. Dorcy Hawaiian Foundation will enable Hawaii's seriously ill children and their families to receive needed emotional and financial support through HUGS unique core program services.

Our goals and objectives are:

Goal 1: To improve the mental well-being and coping skills of HUGS family members and to reduce their sense of social isolation.

Objective 1: To conduct 10 peer support activities in 2024 for mothers of seriously ill children, with 25 moms in attendance at each event.

Objective 2: To conduct 10 peer support activities in 2024 for fathers of seriously ill children, with 25 dads in attendance at each event.

Objective 3: To conduct 10 family events in 2024, with 75 family members in attendance at each event.

Goal 2: To increase HUGS children and siblings' mental well-being and self-esteem.

Objective 1: To conduct 8 respite activities in 2024 with 25 HUGS kids and their siblings in attendance at each respite.

Objective 2: To conduct weekly visits to hospitalized HUGS children.

Objective 3: To host a 3-day/2-night SibCamp for 30 HUGS siblings to build peer support and process their emotions and perceptions of their role in the family in a safe and nurturing environment.

Goal 3: To relieve the financial stress of HUGS families:

Objective 1: To provide monthly food baskets for 75 HUGS families.

Objective 2: To provide emergency airfare assistance to 65 family members whose child is receiving medical treatment on the mainland or away from their Neighbor Island home.

Objective 3: To provide case management services and connection to community resources to 80 HUGS families in need.

Outcome Measures:

- 90% of participating HUGS family members will report a reduction of stress, anxiety, and social isolation as a result of participating in HUGS programs and services.
- 85% of participating HUGS family members will report an improvement in their mental well-being and ability to cope with the HUGS child's illness.
- 80% of HUGS parents will report an increase in their child(ren)'s mental well-being and self-esteem.
- 90% of participating HUGS family members will report a sense of relief from financial stresses because of HUGS financial assistance programs.

Funds from the Dorcy Hawaiian Foundation will support a portion of our direct program expenses like program supplies, as well as a portion of our operational expenses like information technology and software needs, accounting services, office supplies, insurances, postage, telephone/internet service and utilities. Staff salaries will be covered by other funding sources. The Dorcy Foundation funds will also enable HUGS to leverage funding from other foundations for other operational expenses. 
